**2018-2019 ACADEMIC POLICY ON FINAL EXAMINATIONS**

Failure to write the final examination as scheduled may result in a ZERO ("0") for the examination, failure of the course, or other serious consequences. A student may file a petition for a deferred examination with the Academic Dean for reasons of illness or other disability, or for compassionate reasons, setting out the reasons for the deferral. The petition must be accompanied by a medical certificate or other appropriate documentation certifying the reason for the deferral, the inability of the student to write the examination at the scheduled time and, where possible, indicating the period of disability. On the basis of the evidence, the Academic Dean shall decide whether the petition is granted. The decision of the Academic Dean is final.

A student who is scheduled to write more than two final examinations on one day may file a request with the Registrar's office to have one of those examinations rescheduled. The request must be submitted in writing to the Registrar within fourteen (14) days of the exam schedule being posted i.e., February 25<sup>th</sup>, 2019. The Registrar shall decide whether the request is granted.
